CALL FOR ABSTRACTS

Once again, it is time to submit your abstracts for EB2017. The abstract submission deadline is **November 17th, 2016**, which is rapidly approaching. To facilitate the process of identifying Respiration Section related research for submission of your abstracts, the abstract topic categories are listed below. Note that Respiration Section categories are tagged with either *Control of breathing* or *Lung physiology*, except for those associated with the Featured Topics sessions, which are identified by the title of the Featured Topic. This year we will have a trainee poster award competition.

The American Journal of Physiology-Lung Cellular and Molecular Physiology invites nominations for the “Best original research paper published in AJP-Lung between 2012-2014 by a junior author (Assistant Professor, Instructor, Post-doctoral fellow or graduate student.).

The nominee must submit a nomination stating the importance of this paper in the field as well as the contributions of the first author to Dr. Sadis Matalon, Editor AJP-Lung (sadis@uab.edu) with a copy to Ms. McEver (amcever@emory.edu) by **December 1, 2016**. All applications will be reviewed by the Editor and Associate Editors who will chose the winner by secret ballot. **The winner will receive \$500** and a certificate of appreciation at the EB 2017 meeting.

THE USHA AWARDS SPONSORED BY DR. YS PRAKASH

Usha means “dawn” in Sanskrit

Dr. YS Prakash, Deputy Editor of the American Journal of Physiology-Lung Cellular and Molecular Physiology, is soliciting nominations for the Usha awards. The nominee must be a promising trainee (undergraduate or graduate student, or a research fellow (<5 years since being granted the terminal degree (e.g. PhD, MD, DO, DVM), and should have contributed a 1st author abstract to the Respiration Section of the APS for presentation at the APS. Criteria for selection will include the level of excitement regarding the nominee’s future, contribution by the nominee to the work, and the importance of the work to the field. Nominees are to be selected by the Respiration Section of the APS. All applications must be submitted by **Nov 11, 2016**. The **TWO winners will receive \$500 each** and a certificate of appreciation at the EB 2017 meeting.

NEW INVESTIGATOR AWARD

The Respiration Section New Investigator Award (\$1,000 plus reimbursement of the advance registration fee) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the Respiration Section. They must not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). Applicants must have been independent investigators for no more than 8 years at the time of submitting the application. They must receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Respiration Section, evidence for independence and promise (grant funding, peer review activities, etc.) and level of participation in Experimental Biology and APS-related activities.

Although this is not an abstract-based award, awardees are expected to attend the Experimental Biology meeting and make an oral or poster presentation. The candidate must be an APS member in good standing with a primary affiliation in the Respiration Section. Candidates must upload: curriculum vitae, 2 nomination letters from APS members, and 3 reprints. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the Respiration Section Banquet. **All applications must be submitted by November 11, 2016.**

APS FELLOW PROGRAM

The APS has created a Fellow Program (FAPS) to recognize noteworthy scientific and professional accomplishments and outstanding leadership and service to the Society. Requirements for FAPS status include: Regular and/or Emeritus member status for at least fifteen (15) continuous years post-doctoral prior to year of nomination and two (2) written recommendations from current APS Regular or Emeritus members. Candidates must also meet four of the six prerequisites:



- **Demonstrated Society Service:** APS Council or APS Committee, Advisory Group, or other Panel or Editor-in-Chief, Deputy Editor or Associate Editor in any APS-affiliated publication
- **Independent Grant Support/Funding:** Serve as Principal Investigator of peer-reviewed extramural research support from a nationally-recognized agency (i.e.: NIH, NSF, etc.)
- **Publications:** Demonstration of consistent scholarly production in the form of journal articles and book chapters with at least three articles in APS publications
- **Administration:** Serve in a leadership position in academia/industry/government
- **Public Service:** Provide unpaid service in physiology and/or medicine to the community (e.g.: scientific study section; PhUn Week service, etc.)
- **Teaching:** Demonstration of leadership in local, state or national instruction in physiology or medicine

Candidates can be nominated by any active APS Regular or Emeritus Member who is well acquainted with the candidate's professional activities and volunteer involvement. Candidates may also self-nominate. **Application materials, due February 1 each year**, are reviewed by the APS Fellows and Membership Committee. ADVOCACY OPPORTUNITIES

Our representatives need to know how we are impacted by issues such as decreased funding for research and an increase in government imposed regulations. Fortunately, there are several relatively easy things we each can do to increase awareness of the impact of these and other issues on our research careers.

The APS and FASEB have excellent resources to help scientists make their case for support of scientific research. Please take a moment to visit these sites and learn about ways to contact your Members of Congress. With the upcoming midterm elections Members of Congress are campaigning in their home districts, so now is a particularly good time to look for local opportunities for advocacy.

To send an email message, click on “legislative action center” on the left and enter your zip code to get started. You can take advantage of their suggested messages, or craft your own.

The Career Opportunities in Physiology Committee supports a number of APS programs to foster the career development of physiologists of all ages:

Excellence in Professional (MD/DO) Student Travel Awards for EB 2017

Did you host a great MD or DO student in your lab this summer? Are they submitting a first author abstract to Experimental Biology? If so, you'll want them to apply this award! It provides medical student (not MD/PhD) first-authors with up to \$1,800 in reimbursement for travel and advanced meeting registration for Experimental Biology. This award is designed to foster the student's interest in research by aiding in their participation in the Experimental Biology meeting, along with gaining valuable advice from MD/DO "meeting mentors". **Applications are due one week after the Experimental Biology abstract deadline in November.** See <http://www.the-aps.org/md-do> for more details.

APS Video Contest – Help Spread the Word!

APS Presents...Phantastic Physiology Voyage: "Function Follows Form" video contest to encourage undergraduate and graduate students to creatively connect with physiology and engage them with the broader public through a short video contest. Videos should creatively demonstrate and/or explore a specific physiological function in five minutes or less (including credits). The target audience is the general public. The video can be staged as a short play, commercial, news broadcast, talk show, music video, documentary etc. No professional assistance can be provided to produce the video in any manner.
